

## **Juvenile Justice (Care and Protection of Children) Act, 2015**

### **Eligibility Criteria for Chairperson and Members of Child Welfare Committees and Juvenile Justice Boards, State of Punjab**

#### **The application shall be submitted**

- i) To the Directorate Social Security and Women & Child Development Department, SCO 102-103, Sector 34- A Chandigarh by 16.08.2022.
- ii) A separate application shall be submitted for each post.
- iii) Application shall be submitted in the prescribed format with all the supporting documents.
- iv) Incomplete applications shall be considered as disqualified.

**JUVENILE JUSTICE BOARD** consists of one Principal Magistrate and two social workers of which at least one is a woman, as per Section 4 of Juvenile Justice (Care and Protection of Children) Act, 2015

#### **Eligibility Criteria for Social Workers/Member of Board**

- (1) The applicant shall not be less than 35 years of age.
- (2) The applicant shall have at least seven years experience in health, education, or welfare activities pertaining to children or shall be a practicing professional with a degree in child psychology, psychiatry, sociology or law.
- (3) No person shall be eligible for selection as a member of the Board, if he—
  - (i) has any past record of violation of human rights or child rights;
  - (ii) has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence;
  - (iii) has been removed or dismissed from service of the Central Government or a State Government or an undertaking or corporation owned or controlled by the Central Government or a State Government;
  - (iv) has ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act.
  - (v) has been appointed as a member of the board for maximum of two terms, which shall not be continuous.
- (4) The applicant should not :-
  - (i) be holding such full time occupation that may not allow to give necessary time and attention to work of the Board or Committee as per the Act and Rules.
  - (ii) be associated with any Child Care Institution, directly or indirectly, during his tenure as a member of the Board or Committee or have any other conflict of interest.
  - (iii) hold any office in any political party during his tenure, or
  - (iv) be insolvent.

- (5) The appointment of any member of the Board, may be terminated after holding an inquiry by the State Government, if he :-
- (i) has been found guilty of misuse of power vested under the Juvenile Justice (Care and Protection of Children ) Act; or
  - (ii) has been convicted of an offence involving moral turpitude and such conviction has not been reserved or he has not been granted pardon in respect of such offence;
  - (iii) fails to attend the proceedings of the Board consecutively for three months without any valid reason; or
  - (iv) fails to attend less than three-fourth of the sittings in a year; or
  - (v) becomes ineligible as per point no. 3 and 4, during his term as a member.

**Term of Members of the Board:**

- (1) The term of the social worker/ member of the Board will be for the remainder/remaining period of the existing Boards.
- (2) The members may resign at any time, by giving one month's notice in writing to the State Government.

**Child Welfare Committee** consists of a Chairperson, and four other members of whom at least one is a woman and another, an expert on the matters concerning children as per Section 27 of Juvenile Justice (Care and Protection of Children) Act, 2015.

**Eligibility Criteria**

- (1) The applicant shall not be less than 35 years of age.
- (2) The applicant shall have at least seven years of experience in health, education or welfare activities pertaining to children or is a practicing professional with a degree in child psychology or psychiatry or social work or sociology or human development or in the field of law or a retired judicial officer
- (3) No person shall be eligible for selection as a chairperson or member of the Committee if he—
  - (i) has any past record of violation of human rights or child rights;
  - (ii) has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence;
  - (iii) has been removed or dismissed from service of the Central Government or a State Government or an undertaking or corporation owned or controlled by the Central Government or a State Government;
  - (iv) has ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act.
  - (v) has been appointed as a member of the Committee for maximum of two terms, which shall not be continuous.
- (4) The applicant should not :-
  - (i) be holding such full time occupation that may not allow to give necessary time and attention to work of the Board or Committee as per the Act and Rules.
  - (ii) be associated with any Child Care Institution, directly or indirectly, during his tenure as a member of the board or committee or have any other conflict of interest.
  - (iii) hold any office in any political party during his tenure, or
  - (iv) be insolvent.
- (5) The appointment of any member of the Committee shall be terminated by the State Government after making an inquiry, if he:-
  - (i) has been found guilty of misuse of power vested of him under the Juvenile Justice (Care and Protection of Children) Act;
  - (ii) has been convicted of an offence involving moral turpitude and such conviction has not been reserved or he has not been granted pardon in respect of such offence;
  - (iii) fails to attend the proceedings of the committee consecutively for three months without any valid reason or
  - (iv) fails to attend less than three –fourths of the sittings in a year;
  - (v) becomes ineligible as per point no. 3 and 4, during his term as a member.

**Term of Chairperson or Members of the Committee:**

- (1) The term of the Chairperson or Member of the Committee will be for the remainder/remaining period of the existing committees.
- (2) The Chairperson and Members may resign at any time, by giving one month's notice in writing to the State Government

**Note:-** In case of any ambiguity in above mentioned criteria, the criteria mentioned in Juvenile Justice ( Care and Protection of Children ) Act, 2015 shall prevail.
