Juvenile Justice (Care and Protection of Children) Amendment Act, 2021

Eligibility Criteria for Chairperson and Members of Child Welfare Committees and Juvenile Justice Boards, State of Punjab

The application shall be submitted to :-

- i) The Directorate, Social Security and Women & Child Development, Punjab S.C.O. No.102-103, Sector 34- A, Chandigarh by 16.11.2023.
- ii) A separate application shall be submitted for each post.
- iii) Application shall be submitted in the prescribed format with all the supporting documents.
- iv) Incomplete applications shall be considered as disqualified.

<u>JUVENILE JUSTICE BOARD</u> consists of one Principal Magistrate and two social workers of which at least one is a woman, as per Section 4 of the Juvenile Justice (Care and Protection of Children) Amendment Act, 2021.

Eligibility Criteria for Social Workers / Member of Board

- (1) The applicant shall not be less than 35 years of age and more than 65 years of age.
- (2) The applicant shall have at least seven years experience in health, education, or welfare activities pertaining to children or shall be a practicing professional with a degree in child psychology, psychiatry, sociology or with the field of law.
- (3) Any person who was member of previous board can also apply for second term.
- (4) No person shall be eligible for selection as a member of the Board, if he—
 - (i) has any past record of violation of human rights or child rights;
 - (ii) has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence;
 - (iii) has been removed or dismissed from service of the Central Government or a State Government or an undertaking or corporation owned or controlled by the Central Government or a State Government;
 - (iv) has ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act.
- (5) The applicant should not:-
 - (i) be holding such full time occupation that may not allow to give necessary time and attention to the work of the Board as per the Act and Rules.
 - (ii) be associated with any Child Care Institution, directly or indirectly, during his tenure as a member of the Board or have any other conflict of interest.
 - (iii) hold any office in any political party during his tenure, or
 - (iv) be insolvent.
- (6) The appointment of any member of the Board, may be terminated after holding an inquiry by the State Government, if he:-
 - (i) has been found guilty of misuse of power vested under the Juvenile Justice (Care and Protection of Children) Amendment Act; or
 - (ii) fails to attend the proceedings of the Board consecutively for three months without any valid reason; or
 - (iii) fails to attend minimum three-fourth of the sittings in a year; or
 - (iv) becomes ineligible as per point no. 2 and 3, during his term as a member.

Term of Members of the Board:

The term of the social worker member of the Board will be for the remainder/remaining period of the existing Boards i.e. till 09.08.2024.

-sd/-Deputy Director <u>Child Welfare Committee</u> consists of a Chairperson, and four other members of whom at least one is a woman and another, an expert on the matters concerning children as per Section 27 of the Juvenile Justice (Care and Protection of Children) Amendment Act, 2021.

Eligibility Criteria

- (1) The applicant shall not be less than 35 years of age and more than 65 years of age.
- (2) The applicant shall have a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children and has been actively involved in health, education or welfare activities pertaining to children for seven years or is a practicing professional with a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children".
- (3) Member who are already working in Child Welfare Committee as a Member can also apply as a Chairperson.
- (4) The person applying for the post of the Chairperson or member of the Committee shall submit an affidavit, as per Form 49, certifying that the applicant is not barred by any of the conditions laid down in sub-section 4A of section 27 of the Act. The appropriate Government shall then verify the same as per norm.
- (5) No person shall be eligible for selection as a chairperson or member of the Committee if he
 - i. has any past record of violation of human rights or child rights;
 - has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence:
 - iii. has been removed or dismissed from service of the Government of India or State Government or an undertaking or corporation owned or controlled by the Government of India or State Government,
 - has ever indulged in child abuse or employment of child labour or immoral act or any other violation of human rights or immoral acts.
 - v. has been appointed as a member of the Committee for maximum of two terms, which shall not be continuous.
 - vi. If he is working in the implementation of this Act in any Non-Government Organization or any organization, performing such functions which may cause conflict of interest in discharge of their duties as the Chairperson or member of the Committee shall not be eligible for appointment as the Chairperson and member of the Committee.

(6) The applicant should not:-

- i. be holding such full time occupation that may not allow to give necessary time and attention to work of the Board or Committee as per the Act and Rules.
- be associated with any Child Care Institution, directly or indirectly, during his tenure as a member of the board or committee or have any other conflict of interest.

Explanation:

- a) any family members is a member of any non-governmental organization;
- b) close relation is a member of any non-governmental organization;
- c) cases of non-governmental organizations or persons working in a district for rescue and rehabilitation;
- iii. hold any office in any political party during his tenure.
- iv. be insolvent.
- v. associated with an organization receiving foreign contribution.
- vi. a person representing a person who runs a Child Care Institution or member of the Board or Trust of any non-governmental organization.

- (7) The appointment of any member of the Committee shall be terminated by the State Government after making an inquiry, if he:
 - i. has been found guilty of misuse of power vested of him under the Juvenile Justice (Care and Protection of Children) Amendment Act;
 - ii. fails to attend the proceedings of the committee consecutively for three months without any valid reason or
 - iii. fails to attend minimum three –fourths of the sittings in a year;
 - iv. Becomes ineligible as per point no. 2 and 3, during his term as a member.

Term of Chairperson or Members of the Committee:

The term of the Chairperson or Member of the Committee will be for the remainder/remaining period of the existing committees i.e. till 09.08.2024.

<u>Note</u>:-In case of any ambiguity in above mentioned criteria, the criteria mentioned in the Juvenile Justice (Care and Protection of Children) Amendment Act, 2021 shall prevail.
